	A VA Annual Survey was conducted from July 25, 2022 through July 28, 2022 at the Veterans Home of California - Fresno. The survey revealed the facility was not in compliance with Title 38 CFR Part 51 Federal Requirements for State Veterans Homes.

necessary. Hand sanitation is done with an approved sanitizer between hand washing... Sanitation can be done at regular intervals during medication pass...assuming hand washing is not indicated."

On 7/26/22, at 8:10 a.m., Licensed Nurse A was observed administering medication to Resident #16. When administering six (6) units of Novolog Injection, 100/ml (milliliters), Licensed Nurse A did not sanitize their hands and apply gloves to administer the Novolog. During that medication pass, Licensed Nurse A did not remove their gloves after administering the insulin, nor use hand sanitizer and/or apply new gloves before administering two (2) puffs of Symbicort AER 160-4.5. Licensed Nurse A did not sanitize their hands or wear gloves to prevent the spread of infection at any time during Resident #16's medication administration.

On 7/26/22, at 8:20 a.m., Licensed Nurse A stated that they did not wear gloves as they irritated their hands.

On 7/25/22, at 9:00 a.m., Licensed Nurse B stated that the nurses must wear gloves and should sanitize their hands before donning gloves and after administering insulin. Then they should apply new gloves before administering an inhaler and should sanitize their hands after taking off the gloves.

On 7/25/22, at 9:15 a.m., Administrative Nurse A stated that the nurse should have sanitized their hands and put on new gloves between administering the insulin and the inhaler, and should have sanitized their hands before and after their gloves were applied and removed.
