The violations were for the following buildings: Section G- Madison Hall. The Emergency Generator Maintenance and Repairs contract was executed on October 15, 2024. Additionally, the VHCY DCSI contacted North American Power and Control Inc. (NAPC) | affected. The one building in the violation is the only building on emergency power. | Once installed, the facility's Monthly Generator Log Sheets will be updated with the locations of Remote Manual Stop stations. On October 18, 2024, the VHCY DCSI conducted in- service training for all maintenance staff who work with Emergency Generators. The training included NFPA 110 requirements. | The VHCY DCSI will provide a monthly timeline regarding the installation's progress. Once the work is completed, the VHCY DCSI will use the new Monthly Generator Log to conduct monthly inspections of all emergency generator systems, including remote manual stop stations. To ensure ongoing compliance, the VHCY DCSI will perform quarterly audits of these inspections and report compliance to the Fire Life Safety Quality Assurance and Performance Improvement (QAPI) committee until the target goal of a 100% compliance rate for two consecutive quarters. | |
